Menunjuk ketentuan III.1.4 Peraturan Bursa Efek Indonesia Nomor I-E tentang Kewajiban Penyesuaian Informasi, mengenai penyesuaian informasi apabila terdapat perubahan lebih dari 20% (dua puluh perseratus) pada pos Total Aset dan atau Total Liabilitas pada Laporan Keuangan Interim atau Laporan Keuangan Tahunan periode tahun buku berjalan dibandingkan Laporan Keuangan Tahunan Auditan terakhir, dengan ini, kami sampaikan penjelasan sebagai berikut:

In regard to provision III.1.4 Indonesia Stock Exchange Regulation Number I-E concerning on The Obligation of Information Submission, regarding to submission of management explanation in the event if there is any change to more than 20% (twenty percent) of Total Asset and or Total Debt reflecting in the Interim Financial Statement or Annual Financial Statement for the period of current financial year comparing to the last Audited Annual Financial Statement, hereby we submit management explanations as follows:

Peningkatan total liabilitas Perseroan, terutama pada akun Utang bank jangka pendek yaitu tercatat sebesar Rp209,19 milyar pada 30 Juni 2018, mengalami peningkatan sebesar Rp154,86 milyar atau 285% dibandingkan jumlah utang bank jangka pendek pada tanggal 31 Desember 2017 yang tercatat sebesar Rp54,33 milyar. Peningkatan tersebut terutama disebabkan; (i) sebesar Rp23,74 milyar berkaitan dengan transaksi akuisisi atas Sure Filter Thailand yang dilakukan oleh Perseroan pada 29 Juni 2018 (ii) sisanya sebesar Rp131,12 berkaitan pembagian dividen pada tanggal 08 Juni 2018 dan 25 Mei 2018.

The increment in total liabilities of the Company, mainly on Short-term bank loans as of June 30, 2018 is Rp209.19 billion, increase by Rp154.86 billion or 285% compared to Short-term bank loans as of December 31, 2017, which was Rp54.33 billion. The increase was mainly due; (i) of Rp23.74 billion related to the acquisition of Sure Filter Thailand by the Company on June 29, 2018 (ii) the remaining balance of Rp131.12 related to the dividend distribution on 08 June 2018 and 25 May 2018.
