Berikut dibawah ini adalah ringkasan dari sesi tanya jawab pada Paparan Publik yaitu :

The summary of the Q&A session as below :

1. Bapak Bagus Mulandono

Pertanyaan :

Apakah PT Selamat Sempurna Tbk (Perseroan) memiliki rencana untuk melakukan diversifikasi produk selain filter dan radiator?

Jawaban :

Perseroan akan tetap fokus pada produk utamanya, yaitu filter dan radiator. Saat ini Perseroan sedang mengembangkan produk filter untuk *Heating Ventilation Air Conditioning (HVAC)* yang aplikasinya dapat digunakan untuk *Building; Hospital; Offices; dan Industrial*, terutama dalam kondisi Pandemi COVID-19 dimana faktor udara bersih sangat dibutuhkan.

2. Bapak Danang Hamdani

Pertanyaan :

Adakah strategi khusus dari Perseroan ke depan untuk beradaptasi dengan adanya kehadiran mobil listrik (*Electric Vehicles*)?

Jawaban :

Isu terhadap adanya kehadiran mobil listrik (*Electric Vehicle*) sudah cukup lama diantisipasi oleh Perseroan sejak 5 tahun yang lalu. Oleh sebab itu, Perseroan lebih fokus dalam melakukan shifting ke sektor Commercial dan Heavy Duty – saat ini komposisinya 2/3 dari penjualan Perseroan mengingat penerapan *electric* terhadap kedua sektor ini masih memerlukan waktu yang lebih panjang jika dibandingkan dengan Automotive dan Passenger Car – saat ini komposisinya 1/3 dari penjualan Perseroan. Disamping itu, Perseroan juga mengembangkan produk tambahan, yaitu Filter Heating Ventilation Air Conditioning (HVAC) dan Filter Air Purifier untuk Residential.

Question :

Does PT Selamat Sempurna Tbk (The Company) have any plans to diversify its products instead of filters and radiators?

Answer :

The Company will remain focused on its main products i.e. filters and radiators. Currently the Company is developing the filter for Heating Ventilation Air Conditioning (HVAC) systems whose can be applied for Building; Hospital; Offices; and Industrial, especially in the midst of COVID-19 pandemic which the clean air is the main factor needed.

Question :

Is there a specific strategy of the Company going forward to adapt to the presence of *Electric Vehicles*?

Answer :

The issue of the presence of electric vehicles has been anticipated by the Company since 5 years ago. Therefore, the Company is more focused on shifting to the Commercial and Heavy Duty sectors currently the composition is 2/3 of the Company's sales given the application of electric to these two sectors will takes more times, compared to Automotive and Passenger Car - currently the composition is 1/3 of the Company's sales. In addition, the Company also develops additional products, namely Filter Heating Ventilation Air Conditioning (HVAC) and Filter Air Purifier for Residential.

3. Bapak Willy Putra

Pertanyaan :

Faktor apakah yang menyebabkan gross margin dan profit margin pada periode 1H 2020 naik jika dibandingkan dengan tahun lalu, sedangkan jika dilihat penjualan Perseroan mengalami penurunan?

Jawaban :

Faktor yang memberikan kontribusi atas perbaikan gross margin dan profit margin pada periode 1H 2020 adalah adanya penurunan harga bahan baku utama yang berdampak positif terhadap margin Perseroan, yaitu sebesar 8% untuk plat baja, 4% untuk kertas, 8% untuk aluminium, dan 10% untuk brass. Selain itu Perseroan juga melakukan perampingan jumlah tenaga kerja yang dilakukan secara bertahap mulai dari Mei 2020.

4. Bapak Mario Iroth

Pertanyaan :

Apa strategi keuangan Perseroan agar mampu mempertahankan *dividend payout ratio* dan tingkat hutang yang relatif stabil dalam waktu yang sama?

Jawaban :

Perseroan sangat fokus terhadap likuiditas, karenanya *working capital* Perseroan dapat terjaga dengan baik. Sejak awal Pandemi COVID-19, Perseroan cukup responsif dalam negosiasi dengan *supplier* dan mendapatkan support dalam bentuk relaksasi tambahan 30 hari term of payment. Di sisi lain, pembayaran dari *customer* Perseroan sesuai dengan *term of payment* yang diperjanjikan. Terkait pembayaran dividen, dengan adanya faktor *zero debt* dan *cash flow* yang baik, maka Perseroan mampu membayarkan *quaterly dividend* dan mampu mempertahankan *dividend pay out ratio* minimal sesuai dengan *dividend policy* yang dijanjikan Perseroan pada saat *go public*.

Question :

What factors contribute the improvement of gross margin and profit margin in the 1H 2020 compared to last year, while the Company's sales have decreased?

Answer :

The factor contribute to the improvement of gross margin and profit margin in the period 1H 2020 is the raw material price decrease which give positively impacts the margin of the Company i.e. 8% on steel plate, 4% for paper, 8% for aluminum, and 10% for brass. In addition, the Company also pruning the number of workers which is carried out gradually starting on May 2020.

Question:

What is the financial strategy of the Company in order to maintain its dividend payout ratio and relatively have a stable debt level at the same time?

Answer:

The Company is very focused on liquidity, therefore the Company's working capital can be maintained properly. Since the COVID-19 Pandemic, the Company was quite responsive in negotiations with the suppliers and received support in the form of additional relaxation of the 30-day term of payment. On the other hand, the payment from the Company's customers is on schedule with the agreed term of payment. Related to the payment of dividends, supported by the factor of zero debt and good cash flow, the Company is able to pay quaterly dividend and maintain a minimum dividend pay out ratio in accordance with the dividend policy promised before by the Company when go public.

5. Bapak Yoga Saputra

Pertanyaan :

- a) Berapa persentase kontribusi produk filter, radiator, dump hoist, coolant dan brake parts terhadap total pendapatan Perseroan?

Jawaban :

Secara value pada 1H 2020, kontribusi produk filter sebesar 75%, radiator 10%, karoseri 3%, distribusi 31%, dan lainnya (dump hoist, coolant dan brake parts) sebesar 10%.

Pertanyaan :

- b) Berapa komposisi persentase kontribusi untuk produk filter, radiator, dump hoist, coolant dan brake parts terhadap total pendapatan yang diharapkan Perseroan?

Jawaban :

Komposisi yang diharapkan Perseroan terutama pada produk filter dan radiator sudah cukup baik untuk saat ini jika dibandingkan dengan tahun-tahun sebelumnya.

6. Bapak Andrey Wijaya (RHB Sekuritas)

Pertanyaan :

- a) Bagaimanakah perkiraan penjualan Perseroan pada Tahun 2020 dan 2021?

Jawaban :

Pada 1H 2020, Perseroan mengalami penurunan penjualan terkait dampak COVID-19, yaitu penerapan kebijakan Lockdown baik itu terhadap barang maupun orang di berbagai negara. Selanjutnya jika dilihat pada periode triwulan III ini, untuk produk filter dan radiator mengalami pertumbuhan cukup baik jika dibandingkan dengan 1H 2020, khususnya untuk produk radiator mengalami pertumbuhan yang cukup signifikan yaitu sebesar 50% jika dibandingkan dengan triwulan II. Karenanya secara *full year* 2020, Perseroan memperkirakan penurunan penjualan *single digit*, yaitu dibawah 10% dan penurunan terhadap net profit Perseroan yaitu dibawah 8%.

Question:

- a) What percentage of contributions of filter, radiator, dump hoist, coolant and brake parts products to the Company's total revenue?

Answer:

In term of value on 1H 2020, the contribution of filter products is 75%, radiators 10%, karoseri 3%, distribution 31%, and others (dump hoist, coolant and brake parts) is 10%.

Question:

- b) What is the expected percentage composition of the contribution of filter, radiator, dump hoist, coolant and brake parts products to the Company's total revenue?

Answer:

The Company's expected composition, especially in filter and radiator products, currently is fair compared to the previous years.

Question:

- a) What is the Company's sales forecasts in 2020 and 2021?

Answer:

In 1H 2020, the Company's sales decrease related to the impact of COVID-19, i.e. the implementation of Lockdown policy on both goods and human many countries. Furthermore, if seen in the third quarter, for filter and radiator products have a fair growth compared to 1H 2020, especially for radiator products with significant growth of 50% compared to the second quarter. Hence in full year 2020, the Company expects single-digit decrease in sales, which is below 10% and in the Company's net profit is expected decrease below 8%.

Pertanyaan :

- b) Bagaimana dengan rencana ekspansi ke market baru yang akan dilakukan oleh Perseroan?

Jawaban :

Untuk rencana ekspansi ke market baru, tentunya akan tetap dilakukan Perseroan dengan fokus pada dua faktor, yaitu mengikuti berbagai macam pameran perdagangan dalam mencari potensi adanya pelanggan baru dan tetap fokus pada *existing market* saat ini.

Question:

- b) How about the expansion plan to the new market that will be carried out by the Company?

Answer:

For expansion plans to new markets, certainly the Company will continue do by focused on two factors, i.e. participating in various trade fairs as an effort looking for of potential new customers and keep focused on the current existing market.

7. Bapak Rendy Putra

Pertanyaan :

Negara manakah yang *demand*-nya balik paling cepat terkait kondisi pandemi COVID-19?

Jawaban :

Negara yang *demand*-nya paling cepat membaik saat ini adalah USA dimana hal ini juga merupakan salah satu dampak positif dengan adanya *Trade War*, mengingat saat ini tarif bea masuk untuk produk filter dan radiator dari Indonesia ke USA yaitu 0% , jauh lebih rendah jika dibandingkan dengan tarif untuk bea masuk produk filter dan radiator dari China ke USA yang sangat tinggi yaitu sekitar 20-30%. Selain USA, ada negara Thailand yang pertumbuhan permintaannya masih cukup baik hingga saat ini.

Question:

Which countries with the fastest recovery in demand related to the COVID-19 pandemic?

Answer:

Currently, USA is the country with the fastest recovery in demand which is also one of the positive impacts related to the trade war, considering that the current import duty tariff for filter and radiator products from Indonesia to USA is 0%, much lower compared to the import duty tariff of filter and radiator products from China to USA which is very high i.e. approximately 20-30%. Apart of USA, there is also Thailand with fair growth of demand till now.

8. Bapak Ahmad Zainur Rhoiqin

Pertanyaan :

Mengapa *employee turnover* Perseroan cukup besar? Apakah ini merupakan salah satu langkah Perseroan menghadapi dampak COVID-19?

Jawaban :

Sebenarnya bukan *turnover* terhadap tenaga kerja, namun langkah yang diambil Perseroan lebih mengarah pada perampingan tenaga kerja, dimana Perseroan tidak melakukan perpanjangan kontrak atas tenaga kerja yang telah habis masa kontraknya. Hal ini berkaitan dengan dampak penurunan permintaan karena kebijakan *lockdown* di beberapa negara di tengah kondisi Pandemi COVID-19.

Question:

Why the Company's employee turnover likely high? Is this one of the Company's steps to overcome the impact of COVID-19?

Answer:

To be clear, it is not employee' turnover, but the steps taken by the Company are leads downsizing the employee by not extended the tenure of employee contracts if due. This is related to the impact of declining demand due to lockdown policies in several countries in the midst of the condition Pandemic COVID-19.

9. Ibu Herna Permata Sari

Pertanyaan :

Bagaimana pengaruh lesunya industri otomotif terhadap masa depan Perseroan?

Jawaban :

Kondisi lesunya industri otomotif tidak hanya terjadi tahun ini, Perseroan telah beberapa kali menghadapi krisis global, namun Perseroan dapat melewati masa-masa sulit tersebut dengan cukup baik, yaitu terlihat dari kinerja 27 tahun pertumbuhan penjualan tanpa terputus. Pencapaian ini terjadi karena pemilihan target *market* yang tepat dengan fokus terhadap penjualan di aftermarket dan global market.

Question:

How the sluggish of the automotive industries will influence to the Company's future?

Answer:

The sluggish condition of the automotive industries has not only occurred this year, the Company has faced several global crises, nevertheless the Company able to ride through those challenging times, which is can be seen from the performance of 27 years of consecutive sales growth. The achievement is reached by choose the right market with focus on aftermarket and global market sales.

10. Bapak Tonny

Pertanyaan :

Saat ini, CAGR Penjualan (Sales) telah mencapai 21%. Berapakah target CAGR di Top Line dan Bottom Line untuk 5 hingga 10 tahun ke depan?

Jawaban :

Perseroan akan tetap berusaha menjaga kesinambungan atas pertumbuhan CAGR yang disertai dengan pertumbuhan penjualan (*top line*) maupun pertumbuhan laba periode berjalan (*bottom line*). Dalam hal mempertahankan pertumbuhan penjualan akan lebih mudah tentunya jika Perseroan memberikan tambahan *discount* dan *rebate*. Namun hal ini tentunya akan memberikan dampak negatif terhadap *bottom line*. Selanjutnya Perseroan juga harus terus melakukan efisiensi atas biaya dan meningkatkan produktivitas yang dapat memberikan dampak positif terhadap pertumbuhan *bottom line*.

Question:

Currently, CAGR of the sales has reached 21%. What are the CAGR targets on the Top Line and Bottom Line for the next 5 to 10 years?

Answer:

The Company will continue to strive to maintain the CAGR growth sustainably which is also follow with the sales growth (*top line*) and profit (*bottom line*) growth. In terms of maintaining sales growth it will be easier if the Company provides more discounts and rebates. However this will certainly have a negative impact on the *bottom line*. Furthermore, the Company will continue to taken efficiencies on expenses and increase productivity which can have a positive impact on *bottom line* growth.

Pertanyaan :

Bagaimana Perseroan menghadapi kompetisi pada produk filter dengan brand Sakura terhadap produk filter dengan brand lain di luar negeri? Adakah diferensiasi produk Perseroan dengan produk brand lainnya?

Jawaban :

Produk Perseroan seperti filter dan radiator merupakan *safety product* karena merupakan komponen penting bagi mesin, sehingga selain harga, *customer* akan mempertimbangkan kualitas produk Perseroan dibandingkan dengan produk sejenis lainnya di pasar. Kualitas produk yang baik dengan harga yang bersaing merupakan diferensiasi produk Perseroan dengan produk brand lainnya. Dalam berkompetisi, Perseroan selalu mengedepankan kualitas yang dibuktikan dalam jangka waktu yang cukup panjang. Untuk dapat bersaing baik secara lokal maupun global mencakup banyak faktor, yaitu kemampuan untuk dapat menyuplai produk OEM/OES serta standar perakitan sehingga produk Perseroan dapat diterima baik itu di local maupun global market.
