A. Berikut dibawah ini adalah ringkasan dari sesi tanya jawab pada Paparan Publik, yaitu :

1. Bapak Rajo Pangulu

Pertanyaan :

(a) Bagaimana rencana ekspansi Perseroan dalam Jangka Panjang?

(b) Bagaimana kontribusi produk baru Perseroan seperti filter *Heating Ventilating Air Conditioning* (HVAC), air purifier, dan industrial filters terhadap sales selama tahun 2021 ini?

(c) Apakah manajemen berencana memproduksi *battery filters* untuk *Electric Vehicle* (EV)?

Jawaban :

(a) Saat ini Perseroan belum memiliki rencana ekspansi, dikarenakan tingkat utilisasi yang masih cukup dan belum terlalu tinggi, yaitu masih di sekitar 50-60%. Kedepannya Perusahaan belum melihat adanya CAPEX yang besar untuk melakukan ekspansi Perseroan.

(b) Berkaitan kondisi pandemi yang terjadi saat ini, Perseroan mengembangkan produk baru, yaitu *Heating Ventilating Air Conditioning* (HVAC) dan air purifier. Sedangkan untuk industrial *air filters* merupakan produk Perseroan sejak lama. Dari segi perkembangan salesnya, produk HVAC masih membutuhkan waktu, karena mempunyai *distribution channel* yang berbeda dan Perseroan masih dalam tahap proses perbaikan untuk strategi pemasarannya. Sedangkan untuk produk air purifier yang dijalankan Perseroan sejak awal tahun ini, perkembangan salesnya cukup baik dan saat ini sudah terdapat 3 jenis air purifier. Selain itu Perseroan sedang dalam tahap pengembangan *replacement filter* untuk produk air purifier

A. The summary of the Q&A session on Public Expose, as below :

Question :

(a) How the Company's expansion plans in the long term?

(b) How to contribute the company's new products such as Heating Ventilating Air Conditioning (HVAC), air purifier, and industrial filters to sales during 2021?

(c) Does management plan to produce battery filters for Electric Vehicles (EV)?

Answer :

(a) Currently the Company does not have expansion plans, because utilization is still sufficient and not too high, which is still around 50-60%. In the future, the Company has not seen any larger CAPEX for the Company expansion.

(b) Related to the pandemic conditions that occurred recently, the Company developed new products, i.e., Heating Ventilating Air Conditioning (HVAC) and air purifier. Meanwhile as for the industrial air filters is indeed the Company's product for long time. In terms of sales development, HVAC products still need time since the HVAC products have different distribution channels and the Company is still in the process of improving its marketing strategy. As for air purifier products launch by the Company since the beginning of this year, sales progress is good enough and there are currently 3 types of air purifiers. A part of that, the Company is in the development stage of replacement filters for

- (c) Sampai saat ini Perseroan belum memiliki rencana untuk memproduksi *battery* untuk EV, karena fokus Perseroan adalah produk filter dan radiator.

air purifier products with several types of brands (not only Sakura), but also for other well-known brands. The Company sees considerable demand, due to the high level of public awareness at the current health and hygiene factors, thus will give positive impact to the sales growth.

- (c) The Company currently has no plans to produce batteries for EV, as the Company's focus is on filter and radiator products.

2. Bapak Albi Nasuha

Pertanyaan :

Bagaimana strategi Perseroan dalam menghadapi perkembangan mobil listrik? Apakah Perseroan akan memproduksi komponen-komponen untuk mobil listrik?

Jawaban :

Perseroan telah mengantisipasi perkembangan *Electric Vehicle* (EV) sejak beberapa tahun yang lalu, yaitu dengan melakukan *shifting* dari *Automotive* ke *Heavy Equipment Industrial (Heavy Duty)*. Saat ini komposisi untuk *Heavy Duty* adalah 2/3 dan untuk *Automotive* adalah 1/3. Selain itu sebagai salah satuantisipasi EV, Perseroan juga fokus pada produk *Heating Ventilating Air Conditioning* (HVAC) dan air purifier, termasuk *filter replacement*-nya. Sedangkan untuk produk-produk yang terkait dengan EV, Perseroan melihat bahwa EV masih memerlukan filter dan *heat exchange* (radiator), walaupun jumlahnya tidak sebanyak *Combustion Engine filters*. Kedepannya Perseroan akan terus berusaha untuk *mensupply* yang berkaitan langsung dengan produk kami saat ini.

3. Bapak Indra

Pertanyaan :

Dengan kuatnya posisi keuangan Perseroan, mengapa tidak adanya aksi korporasi berupa *buyback* saham?

Question :

What is the Company's strategy in dealing with the development of electric cars? Will the Company manufacture components for electric cars?

Answer :

The Company has been anticipating the development of Electric Vehicles (EV) since few years ago, i.e., by shifting from Automotive to Heavy Equipment Industrial (Heavy Duty). Currently the composition for Heavy Duty is 2/3 and for Automotive is 1/3. In addition as one of the anticipations of EV, the Company also focuses on Heating Ventilating Air Conditioning (HVAC) and air purifier products, including its replacement filters. As for products related to EV, the Company sees that EV still require filters and heat exchanges (radiators), although the number is not as much as Combustion Engine filters. In the future, the Company will continue to strive to supply directly related to our current products.

Question :

With the strong financial position of the Company, why is there no corporate action in the form of stock buybacks?

Jawaban :

Saat ini Perseroan belum memiliki rencana buyback saham dan hal ini merupakan langkah terakhir yang akan Perseroan lakukan apabila diperlukan. Perseroan melihat bahwa likuiditas saham diperlukan, agar jumlah saham yang beredar tidak berkurang, oleh karena hal itu *buyback saham* bukanlah prioritas untuk Perseroan. Kelebihan Likuiditas yang dimiliki Perseroan, lebih diarahkan untuk pembagian dividen, yang mana hingga saat ini secara konsisten Perseroan telah membagikan *quarterly dividend*, yaitu pembayaran dividen sebanyak 4 kali dalam 1 tahun. Tentunya hal ini merupakan suatu hal yang baik untuk Investor.

4. Bapak Handiman S

Pertanyaan :

Apakah ada rencana peluncuran produk baru di luar produk yang telah ada saat ini?

Jawaban :

Untuk produk baru, seperti yang disampaikan oleh Perseroan sebelumnya, yaitu pada awal tahun ini Perseroan baru saja meluncurkan air purifier, termasuk dengan *replacement* filternya, yang mana untuk replacement filter merupakan produk Perseroan sejak lama. Sedangkan untuk produk lainnya, tidak mengalami perubahan, namun lebih mengarah penambahan jenis atau *Stock Keeping Unit (SKU)* yang baru setiap tahunnya untuk menambah kelengkapan dari jenis produk Perseroan.

5. Bapak Ertanto

Pertanyaan :

(a) Kinerja 1H 2021 saat ini sudah lebih baik dari 1H 2019 (*pre-covid*). Bagaimanakah strategi Perseroan ke depannya untuk tetap dapat tumbuh kembali dengan tingkat *Compound Annual Growth Rate (CAGR)* seperti saat *pre-covid*?

(b) Saat ini tingkat hutang Perseroan cukup rendah apabila dibandingkan dengan equity. Apakah ada rencana Perseroan untuk melakukan

Answer :

Currently the Company does not have a share buyback plan and this is the last step that the Company will take if needed. The Company sees that stock liquidity is necessary, so that the number of shares outstanding is not lessen, therefore share buyback is not a priority for the Company. The Company's excess of liquidity, is more aim to the distribution of dividends which is till now consistently the Company has distributed quarterly dividend, i.e., dividend payment 4 times in 1 year. This is certainly a good thing for investors.

Question :

Are there any new product launch plans beyond the current ones?

Answer :

For new products, as mention by the Company before, i.e., at the beginning of this year the Company has launched an air purifier, including with its replacement filter, which is for replacement filter has been the Company's product since long time. As for other products, does not any changes, instead more to the additional of new types or new stock keeping unit (SKU/part number) every year to completeness of the Company's product types.

Question :

(a) The performance of 1H 2021 is currently better than 1H 2019 (*pre-covid*). What is the Company's strategy in the future to still be able to grow with the Compound Annual Growth Rate (CAGR) as during *pre-covid*?

(b) Currently the Company's debt level is quite low when compared to equity. Is there a plan of the Company to leverage by adding debt in

Jawaban :

- (a) Terkait dengan performance pada semester pertama, tentunya di semester kedua ini Perseroan akan tetap fokus dengan (1)terus mengembangkan *market* yang ada, dan (2)juga berfokus terhadap *Cost Reduction Program* (CRP), dimana Perseroan melihat bahwa produktivitas Perseroan belum cukup baik dan perlu untuk ditingkatkan kembali, supaya end-resultnya lebih baik jika dibandingkan dengan tahun-tahun sebelumnya. Hal ini sudah tercermin pada pencapaian 1H 2021 yang cukup baik dan Perseroan berharap secara *full year* akan terdapat peningkatan yang lebih baik lagi, atau bahkan dapat melebihi pencapaian pada tahun 2019.
- (b) Perseroan melihat bahwa tingkat utilisasi fasilitas produksi Perseroan yang masih rendah, yaitu sekitar 50-60%, sehingga Perseroan belum melihat adanya keperluan ekspansi demikian juga penambahan *leveraging* hutang. Pertanyaan :

Strategi apa yang dilakukan Perseroan, sehingga laba dapat meningkat, padahal Perseroan sedang mengalami pandemi seperti sekarang ini?

Jawaban :

Strategi yang Perseroan lakukan, yaitu dengan meningkatkan produktivitas dan melakukan *Cost Reduction Program* (CRP). Jika dilihat dari pencapaian 1H 2021 yang sangat tinggi, disini lain pencapaian pada 1H 2020 tidak terlalu baik karena

order to boost the Company's performance?

Answer :

- (a) Related to the performance in the first semester, for sure, in the second semester the Company will remain focused on (1)continuing to develop the existing market, and (2)focus on the *Cost Reduction Program* (CRP), where the Company sees that the Company's productivity is not good enough and needs to be improved again, so that the end-result is better compared to previous years. This is has been reflected in the achievement of 1H 2021 which is good enough and the Company hopes that full year performance will increase more better, or even exceed the achievement in 2019.
- (b) The Company sees utility of the Company's production facilities still low, approximately 50-60%, so the Company has not seen any need for expansion as well as addition to *leveraging* of debt. However, the Company will continue do the vertical integrated acquisition which is the Company's program to be able to acquire companies related to the Company's production line and will be done conservatively. In the future, if the Company sees a good opportunity, then *leveraging* could be done to improve the Company's performance.

Question :

What is strategy conducted by the Company, so that the profits can be increase, although the Company is faced pandemic today?

Answer :

The Company's strategy is to increase productivity and conduct a *Cost Reduction Program* (CRP). Viewed from the achievement of 1H 2021 which is very high, meanwhile the achievement in 1H 2020 is not good since the pandemic just started.

Pertanyaan :

Apakah ada langkah antisipasi Perseroan terkait perubahan demand terhadap trend *Electric Vehicle* (EV), dimana banyak sparepart menjadi tidak dapat digunakan pada EV?

Jawaban :

Issue mengenai *Electric Vehicle* (EV) memang cukup menarik bagi Investor terkait kebutuhan komponen otomotif kedepannya. Perseroan senantiasa memperhatikan perkembangan dan melihat berbagai *research* mengenai EV. Spesialisasi Perseroan adalah pada produk filter dan radiator, dimana permintaan atas produk filter dan radiator tentu akan menurun sejalan dengan pertumbuhan atas EV. Namun perlu diingat, bahwa Perseroan lebih berfokus terhadap *aftermarket*, yaitu pada pasar pengganti yang secara jangka panjang akan lebih stabil jika dibandingkan dengan OEM. Selanjutnya Perseroan telah mengantisipasi perkembangan EV ini dengan melakukan *shifting* dari produk otomotif ke heavy equipment untuk pertanian, konstruksi, *marine*, pertambangan, dan lain sebagainya, yang kedepannya masih perlu waktu untuk beralih pada menggunakan energi listrik. Selain itu, dalam menghadapi kondisi pandemi saat ini, Perseroan juga berfokus dalam mengembangkan kebutuhan bisnis filter pada produk *Heating Ventilating Air Conditioning* (HVAC) dan *Home Appliances*, seperti air purifier untuk

Therefore the increase is seen significantly in 1H 2021, where the increase approximately $\pm 30\%$ in sales and more than 50% on the bottom line. In the future, the Company sees a lot of potential improvements in all production lines and cost structure, although currently the price conditions of raw materials that are mostly commodity materials increased quite significantly, such as steel plates, paper, rubber, aluminum, copper brass, and so on. The Company continue to do improvements by reduce expense in Labor and Overhead of the Company which impacted to the achievement of the end-result remains good.

Question :

Is there any anticipation step taken by the Company regarding changes in demand to the electric vehicle (EV) trend, where many spare parts become unusable in EV?

Answer :

The issue of Electric Vehicle (EV) is indeed quite attractive for Investors related to the need for automotive components in the future. The Company always pay attention to progress and see various researches on EV. The Company's specialty is in filter and radiator products, where the demand for filter and radiator products will certainly decrease along with the growth of EV. But keep in mind, that the Company is more focused on the aftermarket, i.e., on the replacement market which in the long term will more stable compared to OEMs. Furthermore, the Company has anticipated the development of EV by shifting from automotive products to heavy equipment for agriculture, construction, marine, mining, and so on, which in the future takes time to convert to electric. In addition, in the face of the current pandemic conditions, the Company is also focused on developing the needs of the filter business on Heating Ventilating Air Conditioning (HVAC) and Home Appliances products, such as air purifiers for hospitals, buildings, offices and others. The Company believes that will be ready in

8. Bapak Andreas Kristo

Pertanyaan :

Apakah Perusahaan memiliki rencana untuk melakukan akuisisi daripada membagikan dividen guna memaksimalkan nilai bagi investor?

Jawaban :

Perseroan masih tetap berfokus terhadap *Vertical Integrated Acquisition* yang juga merupakan salah satu program kerja dan harus dilakukan secara konservatif agar tidak menurunkan performance Perseroan. Based on its absorption, Capex till the first semester of 2021 has reached $\pm 70\%$. For Capex in 2022 will return to normal, approx. Rp.100 billion, which is mainly intended for regular and maintenance Capex.

Question :

(a) What is the Company's sales volume growth and target in 2021 to 2022?

(b) What about the increase in raw materials? Can the increase be passed on to the sale price?

Answer :

(a) Projected on a Full Year basis for 2021, sales are expected to increase approx. 20% and net income will increase approx. 15%. Related to the question of sales volume, of course, it cannot be directly related to sales growth, due to the Company is shifting from automotive to heavy duty, which is continuously, will causes the amount of the Company's sales volume not to increase significantly, but in value increases.

(b) Regarding the increase in raw materials, the Company has pricing power to transfer material prices to customers even though this is not done immediately. Within the year, the Company has raised prices for export markets by about 5-7% and for the local market by

The Company's acquisition target for the time being in the coming years is from the South East Asia countries. For the acquisition budget, the Company will take into account carefully and transparent where the Company still gets facilities from few Banks to be able to conduct Bridging Financing if needed. This acquisition activity is carried out conservatively taking into account the future impact on the Company's performance.
